The Challenge

Many business process managers and business continuity management (BCM) teams must work together to perform business impact analysis (BIA) to understand which processes are the most critical to protect and recover and the impacts of a disruption to the organization's strategic objectives. For many organizations, the challenge with BIAs is that they are not completed consistently or frequently enough. They are often completed in spreadsheets and separate systems and they are done differently throughout the organization, if they are done at all.

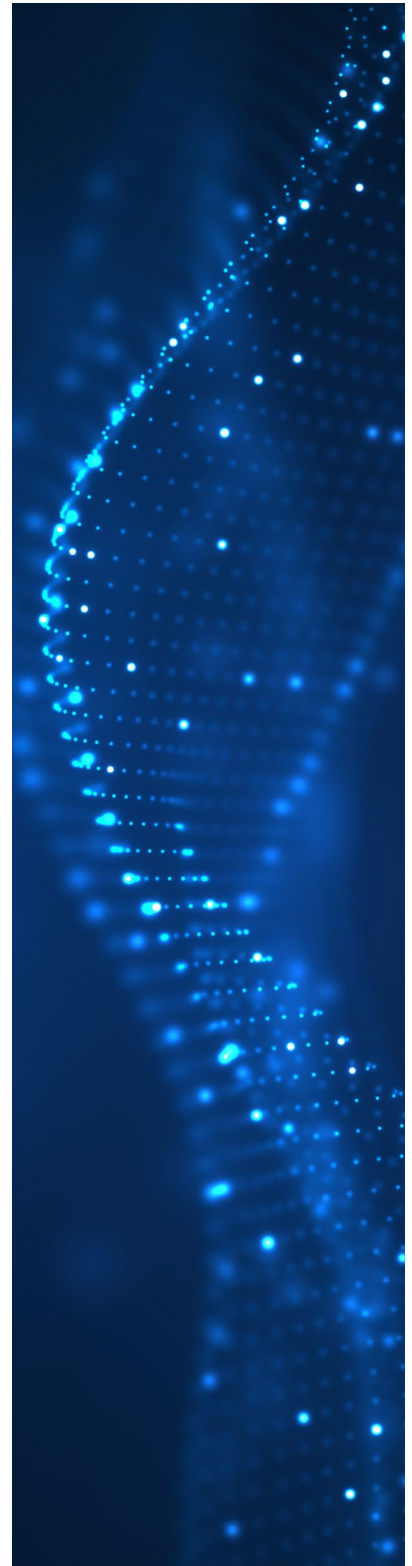

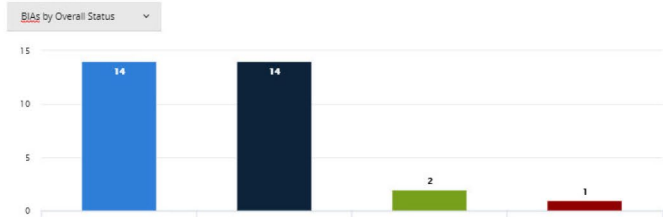
